

## INVITATION FROM A PRIVATE INDIVIDUAL

1. An application form filled out correctly in Spanish or English, signed by the applicant. For children who do not have their own passport but are included in the passport of their mother/father, a separate application form with a photo is also required. For minors, the application must be signed by one of the parents or legal guardians.
2. Two color photographs of good quality, 3.5 x 4.5 cm in size, on a white background, taken within the last 6 months. One photograph must be affixed to the application form.
3. A valid passport, valid for a minimum of three months beyond the last planned date of departure from the Schengen Zone, containing at least two blank pages, and a copy of all its pages (even blank).
4. Other passports: current and cancelled. All passports are accepted only with the addition of a copy of all pages (even blank).
5. If the inviting party permanently resides in Spain:
  - Invitation issued by the Police Department in Spain.
  - A copy of the valid document of the inviting party, confirming their legal stay in Spain for the entire period of the invited person's stay (copy of passport, DNI, residence permit, etc.)
6. If the inviting party permanently resides in Belarus and owns property in Spain:
  - Notarized invitation specifying information about the inviting person, the invited person, travel dates, and the place of residence of the invited person.
  - A copy of the valid visa of the inviting person, valid for the entire period of the invited person's stay (copy of passport, residence permit, etc.)
  - A registration excerpt of private property (Nota Simple). The extract must be issued within the last three months preceding the submission of the documents.
7. Confirmation of family ties (birth certificate, marriage certificate, name change certificate, paternity establishment certificate, Family Book), if the inviting person is a relative.
8. Health insurance policy covering the entire period of stay or first trip and valid for all Schengen Agreement countries. (For travelers to Andorra: the territorial coverage of the insurance policy must extend to both Schengen and Andorra). The policy must cover all expenses that may arise in connection with repatriation for medical reasons, urgent medical care, emergency hospitalization or the death of the applicant during the stay. Insurance coverage of no less than 30,000 euros. Color printout or with a "live" stamp.
9. Round-trip air ticket reservation or confirmation of other means of transport (car, train, etc.). If traveling by own car, provide copies of the car's technical passport, driver's license, and international car insurance (Green Card). If the car is rented, provide a rental agreement. Also, provide a printed itinerary for the planned trip indicating the dates of crossing the borders of foreign countries.
10. Economic guarantees: Certificate from the place of work. Instead of a certificate, it is permissible to provide form 2-NDFL. The relevance of these documents is 1 month from the date of issue. Applicants who have their own business provide a copy of the enterprise registration certificate and a copy of the individual tax identification number (INN).
11. Financial guarantees: 113 euros per person per day for the entire stay (minimum 1020 euros per trip per person). The original bank account statement (on bank letterhead) showing information about the movement of funds for the last three months in the specified account. The applicant can also provide a currency purchase certificate. In the case of sponsorship of the trip, a sponsorship letter in printed form and financial guarantees of the sponsor (bank statement or currency purchase certificate) are provided.

12. Foreign citizens must document their continuous stay on the territory of the Republic of Belarus for the last 6 months (visa to the Republic of Belarus/permit for permanent residence in the Republic of Belarus/temporary residence permit in the Republic of Belarus or a combination of these documents).
13. For minors, it is necessary to provide the original and copy of the birth certificate. For minors traveling without the presence of both parents/guardians, it is necessary to provide a notarized consent for the departure from both parents (with a copy of the first page of the general civil passport). For minor applicants under guardianship, it is necessary to provide consent for the departure of the child from guardianship authorities, regardless of who the child is traveling with (both guardians/one of the guardians/third accompanying person). The notarized consent must be issued no earlier than 6 months before the planned trip to Spain and must fully cover the dates of the trip.

If minors travel accompanied by only one parent/guardian, it is necessary to provide notarized consent for departure from the second parent/guardian (with a copy of the first page of the general civil passport). If the child travels together with parents/one of the parents/another person accompanying the child on the trip, and the parents/one of the parents/accompanying person already have visas/visa, it is necessary to provide their/his/her copy and ticket reservations confirming the accompanying of the child on the trip. Also, consent to the departure of the child is provided in the following cases:

The validity of these documents is 1 month from the date of issue.

- The child and parents/one of the parents/accompanying person return from the trip on different dates;
- The child and parents/one of the parents/accompanying person travel on a trip and return together, but the parents/one of the parents/accompanying person during the stay of the child in Spain plan/plans to leave the territory of Spain for some time;
- The child and parents/one of the parents/accompanying person travel on different flights;
- Parents or one of the parents temporarily or permanently reside on the territory of Spain
