

## STUDIES

1. Application form filled out properly in Spanish or English, signed personally by the applicant. For children who do not have their own passport and are listed in the passport of the mother/father, a form with a photograph is also required. For minors, the application must be signed by one of the parents or guardians.
2. Two color photographs 3.5 x 4.5 cm in good quality with a white background, taken within the last 6 months.
3. Passport, valid for a minimum of three months after the intended date of departure from the Schengen Area, containing at least two blank pages and not older than ten years, and a copy of all its pages (including blank ones).
4. Other passports: valid and cancelled. All passports are accepted only with copies of all their pages (including blank ones) attached.
5. Copies of all pages of the general civilian passport (including blank ones).
6. Confirmation of acceptance to an educational institution, whether public or private, accredited to carry out or continue studies, research, or professional training, **NOT REMUNERATED AS WORK ACTIVITY**, indicating, where applicable: the institution's code according to the National Register of Universities, centers and educational institutions, or the State Register of non-university research centers (in both cases, the competent authority is the Ministry of Education and Science), as well as research centers recognized by the Ministry of Industry, Tourism and Commerce or the Ministry of Education and Science. The document should specify the student's name, the course title and duration, and the number of study hours per week; - Curriculum of the educational program, research, or professional training course. - Document confirming receipt of scholarship or grant, if applicable. - Special documents for a study visa in the field of medicine: a certificate from the General Directorate of Professional Development (Subdirección General de Ordenación Profesional) and Health of the Ministry of Health, indicating the place, medical or educational center, and duration of the internship.
7. Medical insurance policy covering the entire period of stay or the first trip and valid for all Schengen Agreement countries. (For travelers to Andorra: the territorial coverage of the insurance policy must extend to both Schengen and Andorra). The policy must cover all expenses that may arise due to repatriation for medical reasons, urgent medical care, emergency hospitalization, or death of the applicant during the stay. Insurance coverage must be at least 30,000 euros. Printed in color, or with a live blue stamp.
8. Round-trip airline reservation or confirmation of other means of transportation (car, train, etc.). If traveling by private car, copies of the vehicle's technical passport, driver's license, and international car insurance (Green Card) are required. If the car is rented, provide a rental agreement. Also provide a printed itinerary of the planned trip indicating dates of border crossings into foreign countries.

9. Economic guarantees: Employment certificate. The validity of these documents is 1 month from the date of issue. Applicants with their own business must provide a copy of the enterprise registration certificate and a copy of the individual taxpayer identification number (ITIN) document.

10. Financial guarantees: 113 € per person per day of stay (minimum 1020 euros per trip per person). Original bank account statement (on bank letterhead) showing transactions for the last three months in the specified account. The applicant may also provide a currency purchase certificate. In case of trip sponsorship, a sponsorship letter in printed form and financial guarantees from the sponsor (bank account statement or currency purchase certificate) are provided. The validity of these documents is 1 month from the date of issue.

11. For minors, an original and copy of the birth certificate must be provided. For minors traveling without both parents/guardians, a notarized consent for travel is required from both parents (with a copy of the first page of the general civilian passport). For minor applicants under guardianship, consent for the child's travel must be provided by the guardianship authorities, regardless of who the child is traveling with (both guardians, one of the guardians, or a third accompanying person). For minor applicants traveling with only one parent/guardian, notarized consent for travel from the other parent/guardian is required (with a copy of the first page of the general civilian passport). If the child is traveling with parents/one of the parents/another accompanying person who already has visas/visa during the child's stay in Spain, their copy and ticket bookings confirming the child's travel must be provided. The notarized consent must be issued no earlier than 6 months before the planned trip to Spain and must cover the entire travel period. Consent for child travel is also provided in the following cases: Parents or one of the parents temporarily or permanently reside in Spain; The child and parents/one of the parents/accompanying person return from the trip on different dates; The child and parents/one of the parents/accompanying person travel together on the trip and return together, but during the child's stay in Spain, the parents/one of the parents/accompanying person plan/plans to leave Spain for some time; The child and parents/one of the parents/accompanying person travel on different flights.

12. Foreign citizens must documentarily prove their continuous stay on the territory of the Republic of Belarus for the last 6 months (visa of the Republic of Belarus/temporary residence permit of the Republic of Belarus or a combination of these documents).
